Pursuant to Arizona Revised Statutes (A.R.S.) § 38-431.02, notice is hereby given to the members of the Professional Practices Advisory Committee of the State Board of Education (the Committee) and to the general public that the Committee will hold a meeting, open to the public, at 9:00 A.M. on Tuesday and Wednesday, June 9th and 10th, 2020, at the Arizona Department of Education, Room 122, 1535 W. Jefferson, Phoenix, AZ 85007.

Pursuant to the CDC's recommendations for social distancing, the boardroom will be closed to the public, but open to individuals facing disciplinary action against their Educator Certification and attorneys representing an individual with a case scheduled before the Committee on June 9th or 10th, 2020. The Committee may discuss and take action on any item on the agenda. The Committee reserves the right to change the order of items on the agenda. One or more members of the Committee may participate in the meeting by telephonic communications.

Pursuant to A.R.S. § 38-431.03(A)(3), the Committee may vote to go into Executive Session, which will not be open to the public, for legal advice concerning any item on the agenda.

Pursuant to A.R.S. § 15-551(B), § 38-431.03(A)(2), and Arizona Administrative Code R7-2-714, the Committee may vote to go into Executive Session on any matter on the Agenda, which will not be open to the public, for the purpose of taking or receiving the testimony of a pupil or former pupil or for the purpose of discussing or considering records exempt by law from public inspection, including the receipt and discussion of information or testimony that is specifically required to be maintained as confidential by state or federal law.
