# **Background and Discussion**

In light of the upcoming vacancy in the position of Executive Director, at a Special meeting on September 15, 2015, the Board reviewed and adopted the job description for the position of Executive Director, and passed a motion which directed:

"...the Executive Director to post the position of Executive Director as soon as possible, and that a Committee comprised of the Board President Greg Miller; Vice Chair Reginald Ballentyne, III; Superintendent Douglas; Member Hamilton; and Member Schmidt be formed to review applications, conduct interviews, and make further recommendations to the Board regarding filling the Executive Director position."

The Executive Director Hiring Committee met three times to review resumes, conduct interviews, and consider recommendations of the Superintendent. The Committee has recommended a single finalist, Karol Schmidt, for the position of Executive Director.

The Board may also consider the Superintendent's recommendations regarding the position, which may include recommendations made by the Superintendent in her October 8, 2015 letter to President Miller and Vice President Ballantyne.
