The meeting of the Board will be held telephonically, however, the Boardroom will be open for educators facing disciplinary actions only. Those educators and their legal representation can attend the meeting in person at 1535 W. Jefferson St., Room 122, Phoenix, Arizona 85007. To attend the meeting in person, a face covering is required. Please follow all instructions by staff members on where to sit and how to address the Board during the meeting.

Educators facing disciplinary actions and their legal representation: a Request to Speak form must be submitted electronically by Friday, June 19, 2020, at 12:00 PM for Items #6 and #8. The boardroom will be closed to the general public. Information on how the public may attend is outlined below.

Pursuant to A.R.S. §38-431.02 (H), the Board may discuss and take action concerning any matter listed on the agenda.

Pursuant to A.R.S. 38-431.03 (A) (2), the Board may vote to convene in executive session, which will not be open to the public, for discussion or consideration of records exempt by law from public inspection.

Pursuant to A.R.S. §38-431.03 (A) (3), the Board may vote to convene in executive session, which will not be open to the public, for discussion or consultation for legal advice concerning any item on this agenda.
