Pursuant to Arizona Revised Statutes (A.R.S.) 38-431.02, notice is hereby given to the members of the Arizona State Board of Education and to the general public that the Board will hold a Nominating Committee meeting, open to the public, on **Monday, January 27, 2025, at 8:30 A.M.**

The **Monday, January 27, 2025**, State Board of Education Nominating Committee meeting will be a hybrid-access meeting. This means that the public has the opportunity to participate in-person or virtually.

The public will have physical access to the meeting location 30 minutes before the Committee meeting, at 8:00 A.M.

Pursuant to A.R.S. 38-431.03 (A) (2), the Board may vote to convene in executive session, which will not be open to the public, for discussion or consideration of records exempt by law from public inspection.

Pursuant to A.R.S. §38-431.03 (A) (3), the Board may vote to convene in executive session, which will not be open to the public, for discussion or consultation for legal advice concerning any item on this agenda.
