A. Comments for the record

No written comments were received by the deadline.

2. Technical

A. SY24-25 business rule needs and considerations: K-8 Acceleration/Readiness

Chair Rickert introduced this agenda item.

Committee Members discussed the eligibility for Acceleration Readiness and discussed the impacts if schools do not qualify for all or portions of the available points.

Committee Members discussed if all schools have access to the points in the Acceleration Readiness indicator.

Committee Members noted concern about "noise" in the Accelearation Readiness indicator components outside of subgroup improvement.

Committee Members discussed defining mastery in indicators like Grade 3 ELA which is similar to graduation rate's 90% threshold.

Committee Members discussed similarities and differences with federal accountability rules that also consider subgroup performance.

Committee Members questioned if subgroup improvement should actually belong in Acceleration Readiness or if it would be better suited within a different component. Committee Members asked for data regarding subgroup improvements to try to understand if meaningful improvements are occurring. Committee Members suggested considering pulling out chronic absenteeism as a stand alone indicator.

Committee Members expressed concern with the "multiple races" identifier because it can change year over year depending on how a school's registrar inputs the information for a given student.

Committee Members asked for ESSA requires a measurement at the subgroup level. Arizona Department of Education staff responded that it does require that in state accountability only in federal. Committee Members discussed the examply of Wyoming which has seen progress on closing achievement gaps for subgroups.

Committee Members asked if Acceleration Readiness had the same concern as CCRI in the 9-12 model where people pick and choose what they want.

Committee Members discussed considering other non-test based indicators for Acceleration Readiness including re-enrollment/continuous enrollment of students, teacher information, and capture rate.

Committee Members noted that the data included in Acceleration Readiness doesn't necessarily

provide very useful data to schools.

Committee Members suggested considering the relationship between chronic absenteeism and achievement. Other Committee Members noted that data is forthcoming.

B. SY24-25 business rule needs and considerations: Bonus Points

Chair Rickert introduced this agenda item.

Committee Members discussed putting a cap on bonus points and considered capping bonus points based on the percentage of letter grade it can move a school's grade. Other Committee Members suggested assigning bonus points as a proportion of the points a school is eligible for.

Committee Members discussed interest in adding EL bonus points similar to the comparison for science proficiency bonus points.

Committee Members noted that 8th grade science will have different performance due to the departmentalization of science.

Committee Members asked if implementing a cap for bonus points will cause the same concerns seen in Acceleration Readiness.

C. Presentation and discussion on Department's analysis of A-F models

Chair Rickert introduced this agenda item.

Committee Members discussed the "discretization error" where data is aggregated and some data is lost and then it is aggregated again.

Committee Members discussed sharing information about what is wrong with the system and building buy-in on how the committee intends to resolve the issues rather than being prescriptive about the solutions.

3. Future Meeting Dates and Items for Future Agendas

Sean Smith shared that Yassin Fahmy's last day with the Department will be January 14th. The Committee Members discussed inviting Bethany Spangenberg from the Arizona Department of Education to attend the March meeting and discuss the possibility of including MSAA results in CCRI.

Jessica Mueller noted that business rules are expected to be on the March or April State Board of Education Meeting agenda.

Next Meeting is February 3rd at the Arizona Department of Education North Building.
