1. Operational

A. Comments for the record

Jessica Mueller, Policy and Research Administrator for the Arizona State Board of Education, presented on this agenda item. No comments were received by the deadline.

2. Philosophical and Policy

A. A-F Principles of Agreement

Chair Pinkerton introduced this agenda item.

Jessica provided an overview of the Board's A-F Principles of Agreement and the upcoming work by the Board to update those principles.

Members asked if there were any Arizona Department of Education recommended updates for the agreement. Sean Smith, Chief Accountability Officer for the Arizona Department of Education (ADE) noted that there are no recommendations from ADE at this time. Members asked what the impetus is for review/revision of the principles. Jessica noted that during the Board's retreat, there were questions about the achievement of the principles, if items needed to be more descriptive, etc. and technical advisory committees have asked what the Board wants the A-F labels to communicate.

Members noted that other technical advisory committees have looked at the piloting piece and a focus on ensuring that there is the ability to pilot test at schools. Jessica explained that pilot testing has been a focus for indicator scoring but that it could also be considered for the summative grade.

Members emphasized the importance of pilot testing for schools. Members noted that pilot testing and ensuring understanding of the system is important for schools and for their communities. Jessica shared that the communication regarding A-F is something the Board considers as well.

Jessica asked what members' thoughts are about including Appeals as part of the Principles of Agreement. Members shared that their experience with Appeals has not necessitated such an agreement but noted that there wouldn't be a concern with creating one.

Members noted that there are challenges related to students that are straddling multiple school environments, for example partially attending a brick and mortar school and partially attending an AOI. The students that are going back and forth between different

environments are hard to capture within the A-F models. Members noted that additional information about who is captured in various calculations is important. Members noted that students in multiple schools/environments is particularly challenging if a student's secondary enrollment is outside of the district/LEA.

Members noted that some schools have created requirements where the resident district has to approve external courses, online schools are only able to offer full-time enrollment, etc. Members responded that creating such rules makes data more orderly but can negatively impact students.

Sean discussed the sampling errors that appear and noted it comes up particularly in the online space.

3. Technical

A. Discussion on SY2023-2024 A-F Appeals for Online Schools

Chair Pinkerton introduced this agenda item.

Jessica presented on this agenda item to share about the A-F appeals that were addressed for AOI schools. This year AOI schools had appeals that were about corrections to withdrawal codes and self-reporting but there were not any appeals that pointed to a bigger systematic issue that would need to be addressed and corrected.

B. Presentation and discussion on Department's analysis of A-F models

Chair Pinkerton introduced this agenda item.

Sean presented on this agenda item and provided an overview on the Indicator Scoring Analysis document.

Sean highlighted the "balance" component of the scoring analysis. Sean noted that this document is "observing" issues in the system but not necessarily providing solutions to the issues.

Members asked if Sean had something in mind to address the balance issue and how to award points in a more balanced way.

Members shared an example of Michigan who identifies a goal and points are based on success towards that goal and noted that it does require that a good goal is set.

Sean highlighted the "scaling" component of the scoring analysis.

Members questioned if community members are impacted by indicator scoring. Members asked if removing a summative grade would push community members to consider and understand the indicator grades.

Sean highlighted the "discretization error" component of the scoring analysis.

Sean highlighted the "sampling" component of the scoring analysis.

Members noted that graduation is a large concern for AOI schools because they get students later in high school who are significantly behind. Members expressed interest in looking at 9th and 10th grade students who are getting off track for graduation and implementing interventions to get them to graduation. Or having there be bonus points/weight for students that have been behind and get to graduation. Members noted that the same idea would also apply to CCRI.

Jessica noted that members have asked previously for a chart outlining which students are included in each calculation which ADE has created and could potentially be added to the business rules.

4. Future Meeting Dates and Items for Future Agendas

Chair Pinkerton introduced this agenda item.
